Storage:

In originally closed containers, ALBODUR® polyols and oil polymers are stable for 6 months when stored at recommended temperature range from $+5^{\circ}$ C to $+30^{\circ}$ C. The products should be protected from atmospheric oxygen.

A turbidity of the products due to coldness is reversible and can be removed by heating up to more than 40 °C.

ALBERDINGK BOLEY GmbH assures, that the data mentioned under "specification" are stable for 6 months after delivery date, if the product is stored under the recommended conditions. A longer storage does not mean that the product is not usable anymore, but we recommend to check the specification data before use.
